PLEASE READ THE ENTIRE LABEL BEFORE USE

FIRST AID: If swallowed DO NOT induce vomiting. For advice contact the National Poisons Centre 0800 POISON (0800 764 766) or a doctor immediately. If spilt on the skin, remove contaminated clothing and wash affected areas of skin. DO NOT SCRUB THE SKIN. If concentrate is splashed in the eyes, flush with running water for at least 15 minutes. Seek medical attention.

PERSONAL PROTECTION: Avoid skin and eye contact and inhalation of spray mist. When mixing or applying wear waterproof gloves, eye protection, boots and overalls. DO NOT eat, drink or smoke while using. Wash splashes of concentrate from skin immediately. Remove protective clothing and wash hands and face thoroughly before meals and after work. Wash protective clothing daily after work.

STORAGE: Store in original container, tightly closed, away from foodstuffs.

DISPOSAL: Triple rinse empty container and add rinsate to the spray tank. If recycling, replace cap and deliver clean container to an Agrecovery depot. Alternatively crush and bury in an approved landfill. Dispose of product only by using according to the label, or at an approved disposal facility.

DIRECTIONS FOR USE

It is an offence to use this product on animals.

Depth Charge is a viscous, non volatile, low toxicity adjuvant to assist the sinking and controlled dispersion of contact herbicides in the aquatic environment.

APPLICATION

IMPORTANT: Do not entrain air during mixing or product may not sink as desired.

MIXING INSTRUCTIONS:

Depth Charge should be mixed 1:1 by volume with 200 g/litre diquat products (e.g Reglone)

1. For small volumes mix in bucket or suitable open top container ensuring minimum air entrainment.
2. For larger volumes add diquat product to tank, start pump on full bypass and slowly add Depth Charge. Mix until a smooth product is achieved.

Apply mixed product at 40 - 60 litres per hectare.

NOTES FOR APPLICATION:

Conventional spraying equipment with some modifications is suitable.

The mixture of diquat product and Depth Charge is applied neat.

Do not add wetting agents or other additives.

In drains and waterways do not treat where water is flowing more than 1km/hr.

The mixture is not effective in turbulent or muddy waters or where suspended organic matter is above 1ppm.
